I. **TERM OF LEASE:** The term of this lease is monthly with the rent due on the **First** day of each month.

II. **OPTION TO BUY:** LESSEE may apply 50 percent of the rent paid towards the purchase price of the instrument if purchased within 30 days of terminating this agreement.

III. **LOSS:** In the event said property is lost, stolen, or destroyed, LESSEE agrees to pay ROCK TO BACH upon demand the total value of the instrument, as shown above, less the amount of deposit already paid, unless instrument insurance is selected and not expired.

IV. **INSURANCE:** If insured, then the instrument shall be fully covered against fire, theft or **accidental** damage. Replacement of parts *other than* normal maintenance will be provided under this policy. A **\$30 deductible** is required for each claim. V. **DEFAULT:** If payment is not received within 5 days of due date, then a \$10 late fee will be assessed. If payment is not received within 10 days of due date, then LESSEE is in DEFAULT and insurance policy shall lapse and coverage shall not apply. If DEFAULT is remedied, then this instrument must be inspected by ROCK TO BACH prior to insurance reinstatement.

VI. **LESSOR'S REMEDIES:** If LESSEE is in DEFAULT, ROCK TO BACH may immediately terminate this lease by mailing written notice to LESSEE at the address shown above. Repossession of said property by LESSOR shall not constitute a waiver of LESSOR'S right to collect all unpaid installments of rent owed pursuant to this lease.
